Sept 2012: Pulled 120 joints 1-1/2" tubing from well. Fished packer from well. Set CIBP at 5966'. Blue Jet ran CBL and found TOC at 4515' with a DV tool at 4090' and TOC at 560'. RD and MOL. Note tapered casing: 7" to 4.5" at 4140'.

Plugging: Plug #1 with 15 sxs on top of CIBP at 5966'; Ismay from 5427' to 5327' with 12 sxs; Hermosa from 4690' to 4590' with 12 sxs; Organ Rock from 3924' to 3733' with 30 sxs; DeChelly from 3183' to 3083' with 30 sxs; Chinle from 2250' to 2120 with 30 sxs; 8-5/8" casing shoe from 1541' to 1441' with 30 sxs; Dakota and Surface plug from 226' to surface inside with 50 sxs. Cut off wellhead and set p&a marker.
