


## Sooner #1E

Section 21, T26N, R7W, N.M.P.M., Rio Arriba County, NM



Drill ground bed approximately 111' south east of Sooner #1E well head at staked location. Install dual well solar at staked location. Install cable to new ground bed and to Sooner #1E well head. Also plow in neg cable to the Sooner #1 well head at 605' in road. There will be 3 Enterprise pipe line crossing. There should not be any boulders for drilling 20', of casing should be good.

Sooner #1E Cables:

Negative: 725'

Positive: 15'

Total Ditch: 740'
