Operator, Lance Oil & Gas Company, Inc. respectfully requests a change in the Application to Drill on this well:

In a sundry approved 3/8/05, Lance Oil & Gas Company changed the casing and cementing to a 11" surface casing hole to conform to Beeman Bros Rig #22 set up. However, Lance Oil & Gas Company, Inc. has encountered drilling issues with the bit size required to drill an 11" hole and has since equipped the Beeman Bros rig to accomodate a bit to drill a 12-1/4" surface casing holes. The cementing volume will be increased accordingly. "Waiting on Cement" time will be as per cementing company recommendations, but will in no event be less than 6 hours.

Therefore, Operator, Lance Oil & Gas Company, Inc., repsectfully requests that the APD be further amended to drill an 12-1/4" surface casing hole and increase the cement volume accordingly. No other changes to the APD approved 5/31/2000 are requested at this time.
