Pressure test csg to 1000 psi/ for 15 min - OK.

Drilled 6-1/4" hole to 7318'. TIH w/4-1/2" 11.6# L-80 LT&C csg & set @ 7318' on 4/24/05. Cemented csg w/150 sx (294 cf) Dakota Lite cmt w/2% KCL, 0.1% Halad 9, 0.2% HR-5, 5#/sx gilsonite, & 0.25#/sx Flocele mixed @ 11.5 ppg, & yield of 1.96 cf/sx. Tail w/470 sx (832 cf) Dakota Lite cmt w/2% KCL, 1% Halad 9, 0.2% HR-5, 0.25% flocele, 5#/sx gilsonite, 8% silicalite mixed at 12.5 ppg, 8.41 gal/sx & yield of 1.77 cf/sx. Circ. 60 bbls cmt to pit. Will pressure test during completion operations.
