TIH w/ 6-1/4" bit, circ. clean, COUT TD. TIH w/ pre-perfed 5-1/2" 15.5#, J-55, LT&C liner & set liner @ 2911' w/ TOL @ 2669' (43' overlap into 7" shoe). Mill out perf plug intervals from 2714'-2736', 2757'-2780', 2823'-2844', 2866'-2909', circ. hole. TIH w/ 2-3/8" 4.7#, J-55, EUE tubing (90 jts) and landed @ 2901', SN @ 2865'. ND BOP & NU WH, RU rod equipment & run on 4/18/05, load tbg & test to 500 psi. RD & released rig 4/18/05.
