Started natural surging C/O fill. Surged 1 day. RIH w/5-1/2" (9 jts) 15.5#, J-55 pre-perf'd liner & set @ 3378' w/TOL @ 3033' (35' overlap into 7" shoe). Perfs @ 3228' - 3376' = 148' = 296'. PU perf mill and milled out perf plugs. Circ. clean. RIH w/106 jts 2-3/8", 4.7#, J-55 tbg & set @ 3370' w/SN @ 3358'. ND BOP & NU WH. RU to run rods. 5/4/05 RIH w/rods & pump. Spaced out. PT to 500# - OK. RD & released rig 5/4/05.
