5/9/05 MIRU Mote #1. Spud 12-1/4" hole @ 0900 5/9/05. Drill ahead to 221'. Circ. hole. RIH w/7 jts 9 5/8", 32#, H-40 ST&C casing & set @ 218'. Pumped preflush of 4 bbls H2O, then pumped 67 sx (108 cu - 19 bbls slurry) Type 1-2 Portland cement w/20% flyash & 14.6 ppg into casing. Dropped plug and displaced with 13 bbls H2O. Circulated 3 bbls to surface. WOC. Install wellhead. RD & released rig. PT will be conducted by the drilling rig before drilling continues.
