Perforate Point Lookout & Lower Menefee 5272-5328' (24 shots). RIH with packer and 3 1/2" workstring, set packer at 5,054'. Foam frac stage 1 with 45,000 lbs 20/40 Brady and 15,000 lbs 20/40 SLC resin coated proppant. Flowback frac, POOH with packer and tubing. Set cast iron bridge plug @ 5,150'. Perforate Cliffhouse and Upper Menefee 4,762 - 5,092 (25 shots). RIH with packer and 3 1/2" workstring, set packer at 4,525'. Foam frac Cliffhouse & Upper Menefee with 45,000 lbs 20/40 Brady and 15,000 lbs 20/40 SLC resin coated proppant. Flowback frac, drillout bridge plugs @ 5,150' and 5,447'. Cleanout wellbore. Land 2 3/8" production string @ 7,285'. Place on line as a Dakota, Gallup, Mesaverde commingled producer.

Allocations will be calculated by the subtraction method and submitted within 30 days.
