13. Describe Proposed or Completed Operations

It is intended to deepen the existing Basin Fruitland Coal well to approximately 3699' into the Pictured Cliffs formation. It is anticipated the Pictured Cliffs is not productive in this wellbore. The existing tubing & liner will be pulled. The hole will be circulated clean. Additional footage will be drilled (90' below the current TD) and again the hole will be cleaned. The well will be reconfigured with a 5-1/2" 15.5# J-55 liner set at approximately 3280'-3699'. A mudlogger will be on location to monitor the gas in the Pictured Cliffs. The well will then be recavitated. *Sump request in non-prod. P.C. granted 5/19/05. JET*

Bureau of Land Management Conditions of Approval:

- 1) If this well is located in a Specially Designated Area (SDA), compliance with the appropriate seasonal closure requirements will be necessary.**
- 2) Pits must be lined with an impervious material at least 12 mils thick. The pit must be fenced on three (3) sides during workover operations and on the 4th side after the rig moves off location. Pits must be closed within 90 days of completion of the workover operations. Prior to closing the pit the liner must be cut off at mud level.**
