



Pit multi-use drilling and completion to avoid additional site disturbance and pit will be considered out of service once production tubing set. Pit to be constructed, operated and closed in accordance with NMOCDC guidelines and Williams procedures.

This pit will also be used for the new Fruitland Coal well Rosa 201A (API# 30-039-27417) to be located on the same common well site pad. The pit will remain in use until both wells are completed and tubing set.
