Surface: Set 9-5/8", 36.0#, J-55, ST&C csg @ +/- 275' w/200 sx cmt w/additives mixed @ 14.6 ppg & 1.41 cuft/sx. Circ cmt to surf.

Intermediate: Set 7", 20.0#, J-55, ST&C csg @ +/- 3,000' w/300 sx lite weight cmt w/additives mixed @ 11.4 ppg & 3.03 cuft/sx followed by 150 sx cmt w/additives mixed @ 14.6 ppg & 1.41 cuft/sx. Circ cmt to surf.

Production: Set 4-1/2", 10.5#, J-55, ST&C csg in 9.0 ppg mud @ TD (7,025') w/300 sx Premium Lite HS cmt w/additives mixed @ 12.5 ppg & 2.01 cuft/sx followed by 100 sx cmt w/additives mixed @ 14.2 ppg & 1.52 cuft/sx. Top of cmt will be circ +/- 500' into the csg overlap (TOC @ +/- 2,500').

-Production hole will be drilled with air.
