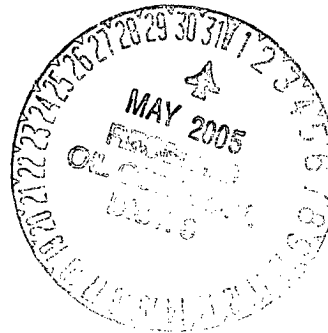

On 5/8/05, set 13 jts of 5 1/2", J-55, 15.5#, LT&C Liner, run to 3,615'. Top of liner hanger is at 3,078'. Perforations are from 3,190' - 3,510', 4 SPF, 0.48", 520 holes, 120 degree phasing. On 5/10/05 ran back in hole with 116 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 3,596', return well to sales on 5/10/05.
