Drilled 12 1/4" hole to 305' on 4/28/05, set 9 jts of 9 5/8", H-40, ST&C, 32.3# casing at 297'. Cemented w/200 sx (37 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 20 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 4,107' on 5/3/05, set 95 jts of 7", J-55 LT&C, 23# casing at 4,093'. Cemented lead w/485 sx (125 bbls) 50/50 POZ w/3% Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/95 sx (24 bbls) STD, 4/10% Halad 344. Well circulated fully. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 8,230' on 5/6/05, set 200 jts 4 1/2", J-55, LT&C, 11.6# casing at 8,216'. Cemented lead w/285 sx 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/665 sx 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. Circulated a total of 82 bbls cement to surface. No tubing in hole at this point.
