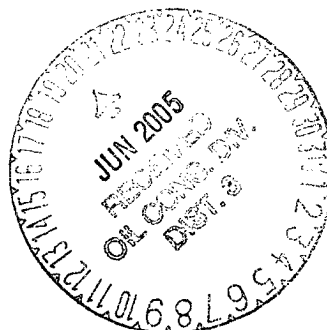

Plug down @ 10:30 am on 05/24/05. Circulate 15 bbls cement to surface. WOC. NU BOP. Test casing & BOP to 600 psi - ok.
