Pumped 50 sx (81cu - 15bbl slurry) Type 1-2 Portland cement with 20% fly ash @ 14.5 pps. Drop plug and displaced w/ 9 bbl H2O. Circulated @ .25 bbl. WOC. Install wellhead. PT will be conducted by the drilling rig and will be shown on next report. Rig down and move out.
