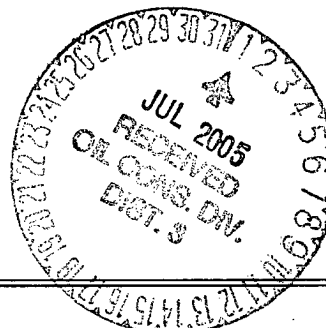

We spud this well on 6/24/05.

We drilled 12 1/4" hole to 285', and ran 9 5/8", 36#, J-55, ST&C Casing, landed @ 313.63' KB (KB=5'0"). Cemented casing on 6/25/04 with 152 sks 15.6# Class B Cement, plus 2% CACL2 plus 0.25 lb/sk Celloflake, yield 1.18, 179.36 cu. ft. We used 3 centralizers on the bottom 3 joints. Circulated 9 bbls of good cement to surface. Wait on cement +/- 18 hours.
