13. Describe Proposed or Completed Operations

It is intended to deepen this existing Basin Fruitland Coal well to approximately 3443' - into the Pictured Cliffs formation. It is anticipated the Pictured Cliffs is not productive in this wellbore. The existing tubing and liner will be pulled, the hole will be circulated clean, additional footage will be drilled (90' beyond current TD of 3353' or last significant coal) and again the hole will be cleaned and then a reconfigured 5-1/2" 15.5# J-55 liner will be installed from approximately 2990' - 3443'. A mudlogger will be present to insure Pictured Cliffs gas isn't encountered. -sump request granted 6/17/05 -verb P. Clugston

- 2) Pits must be lined with an impervious material at least 12 mils thick. The pit must be fenced on three (3) sides during workover operations and on the 4th side after the rig moves off location. Pits must be closed within 90 days of completion of the workover operations. Prior to closing the pit the liner must be cut off at mud level.**
