On 1/24/05, set 14 jts of 5 1/2", J-55, 15.5#, LT&C Liner, run to 4,333' with 0 sx of cement. Top of liner hanger is at 3,867'. Perforations are from 4,108' - 4,317', 4 SPF, 72 holes. On 1/24/05 ran back in hole with 78 jts of 2 3/8" tubing J-55, 4.7#, LT&C, end of tubing set at 4,321', return well to sales on 1/27/05.
