RIH w/ 75 jts of 7" 20#, J-55, ST&C casing landed @ 3145'. Pumped preflush of 10 bbls of FW + 10 bbls mud clean + 10 bbls FW ahead of lead scavenger cmnt- 9 sx (27 cf - 5 bbls slurry), Premium Lite. Then cemented lead w/ 370 sx (788 cf - 140 bbls slurry) Premium Lite Class B w/ 3%CaCl₂, .25#/sx Cello-Flake. Tailed w/ 90 sx (124 cf - 22 bbls slurry) Type III cmnt. w/.25#/sx Cello-Flake, 3% CaCl. Bumped plug @ 06:21 hrs 6/17/05. 65 bbls cmnt returned to surface. ND & RD, rig released 6/17/05 @ 13:00 hrs.
