1/10/05 Spud 8 3/4" surface hole. Drilled to 138'. Ran 3 jts. (126.22') of 7" 23#, J-55, LT&C casing and set at 135' KB. Cemented with 50 sx (64 cu.ft.) of Type III with 3% CaCl₂ and 1/4 #/sk celloflake. Circulated 4.0 bbls. of good cement to the surface. Hole was staying full.

01/11/05 Nipped up the BOP and pressure tested the casing to 600 psi.

1/15/05 TD well 6 1/2" hole at 1990' KB. Ran 50 jts (1949.26') of 4 1/2", J-55, 10.5#, ST&C new casing and landed at 1956' KB. Insert float at 1945' KB. Cemented with 170 sx (396 cu.ft.) of Type III 2% SMS cement with 1/4 #/sk celloflake and 5#/sk gilsonite, followed by 100 sx (140 cu.ft.) of Type III with 1/4 #/sk celloflake, 2% CaCl₂ and 5# sk gilsonite. Bumped plug to 1500 psi. Circulated 10 bbls of good cement to surface.
