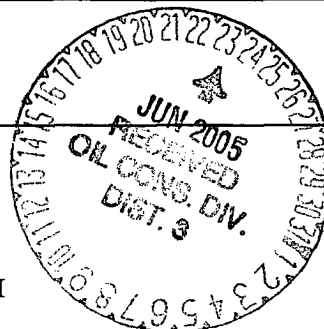

6/3/05 MIRU Mote #1. Spud 2 1/4" @ 09:00 6/3/05. Drilling ahead to 221'. Circulate hole. Run 7 jts of 9 5/8" 32# H-40 STC CSG and set @ 218'. Pumped pre flush 4 bbls H2O. Pumped 67sxs (108cu - 19bbl slurry) Type 1-2 Portland cement with 20% fly ash @ 14.5 pps. Drop plug and displaced w/ 12 bbl H2O.PT @ 500psi. Did not circulate WOC. Tace cement @37' w/3/4" pvc. Mix and pump 15sxs(21cu-4bbls slurry) Type 1-2 portland neat cement. RD and installed wellhead. MO 6/3/05 Pressure test will be conducted by the drilling rig and will be shown on next report. Rig down and move out.
