Cement with 200 sks Class B, 2% CaCl2, 1/4#/sk floccle (236 cu.ft.). Plug down @ 1:45 pm on 07/01/05. Circulate 17 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
