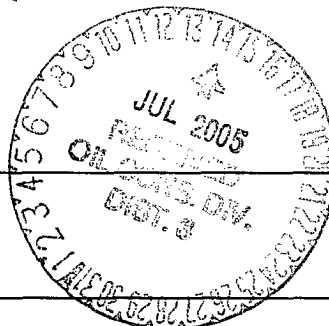

Pumped 19sxs(59cu-10bbls)scavenger cement, w/3%CaCl2, .25pps Cell-o-Flake, 5pps LCM1, .4% FL52, .4%SMS. Cemented lead w/346sxs(736cu-133bbls) prem lite w/3% CaCl2, .25pps Cell-o-Flake, 5pps LCM1, .4 FL52, .4 SMS. Tail in w/90sxs(124cu-22bbls)Type 3 cmt w/ .25% Cell-o-Flake, 1% CaCl2, .2% FL52.
