Spud 12 1/4" hole on 7-7-05. Run 8-5/8" 24# J-55 casing. Land @ 130', float collar @ 88'. Cement w/95 sx Class "B" neat w/2% CaCl2 w/1/4# celloflake/sx (112 cu ft total). Displace w/6 bbls water. Circ 6 bbls cement. Pressure test BOP to 900#, held ok.
