Drilled 6 1/4" hole to 3,680' on 6/18/05, set 91 jts 4 1/2", J-55, LT&C, 11.6# casing at 3,662'. Cemented lead w/275 sx (71 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (27 bbls) Powder River basin. Circulated 15 bbls cement to surface. No tubing in hole at this time.
