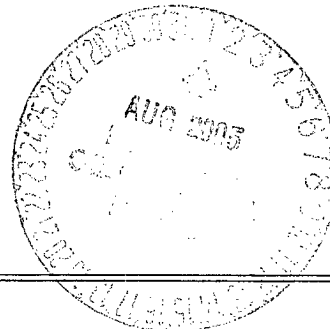

Drilled 12 1/4" hole to 298' on 6/9/05, set 10 jts of 9 5/8", H-40, ST&C, 32.3# casing at 298'. Cemented w/175 sx (36 bbls) "B" neat cement. Circulated 2 bbls of cement to surface. Test casing to 1500 psi.

Drilled 6 1/4" hole to 3,610' on 6/22/05, set 89 jts 4 1/2", J-55, LT&C, 11.6# casing at 3,600'. Cemented lead w/275 sx (71 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (19 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. Circulated 20 bbls of cement to surface. Landed 2 3/8" production tubing at 3,461'.
