Cemented lead w/275 sx (71 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (19 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. Circulated 15 bbls cement to surface. No tubing in hole at this time.**
