Dear Mr. Anderson & Mr. Velasquez:

XTO Energy Inc. was recently contacted by the City of Aztec concerning the Hampton D #1E wellpad. There were a number of concerns expressed about the visibility of the wellpad as seen from the Kokopelli Subdivision. XTO desires to maintain its good neighbor relationship with local residents and therefore, XTO will attempt to move, modify and re-construct the wellpad to address these concerns.

XTO will improve the wellpad and its appearance to address these issues as follows:

- 1. The well will be re-staked and re-surveyed approximately 100' due east of its current location.
- 2. The wellpad will be re-constructed and extended approximately 100' to the east in order to accommodate the new wellhead location.
- 3. XTO is currently reviewing its option with the landowner to bring access into the wellpad from an existing dirt road east of the location in order to minimize the amount of oilfield truck traffic that will use South Flattop Road.
- 4. XTO will attempt to remove the wellpad access road from the western side of the current wellpad in order to change the existing slope from its current appearance to a more appropriate angle and slope.
- 5. XTO will also attempt to round and re-contour the western edge of the current wellpad to enhance its appearance from the Kokopelli Subdivision.
- 6. Any natural drainage that has been encountered during construction of the wellpad will be re-routed to provide proper drainage away from and around both the wellpad and the reserve pit.
- 7. The possible use of low-profile production-related equipment will be reviewed by XTO.
- 8. To provide the benefit of visual mitigation and location safety, the wellpad will be fenced and slatted as required by City Code.
- 9. Dust mitigation procedures will be utilized during the re-construction of the new wellpad as needed.

From the Intersection of Browning Parkway and C.R. 3000 in Farmington, NM

Take C.R. 3000 North for 1.3 miles.

Turn right and go east 0.8 miles on (C.R. 3950)

Turn right and go east 0.6 miles on (C.R. 3940)

Turn left and go north 0.1 miles to staked location twinned with the Hudson No. 3E
