Lead w/11 sxs(26cu-5bbls) Type 3 cement w/3% CaCl2 and .25 pps of Cell-o-Flake. Tailed w/184sxs(236cu-42bbls) Type 3 cement w/3% CaCl2 and .25 pps of Cell-o-Flake. Drop plug and displace w/19bbls FW. Plug in place @ 0130 hrs 8/11/05. Circulated 19bbls to reserve pit. WOC. NU BOP PT BOP and casing to 600 psi/30 min, ok. Drilling ahead.
