XTO Energy, Inc. requests approval for an exception to NMOC Rule 303-C to permit DHC of production from the Blanco Mesa Verde & the Otero Chacra in the Dawson Federal #1C. XTO Energy, Inc. proposes to downhole commingling these pools upon completion of the Otero Chacra zone.

Allocations are based upon a 9-section EUR and are calculated as follows:

Blanco Mesa Verde	Gas	69.75%	Oil	100%
Otero Chacra	Gas	30.25%	Oil	0%

Both pools are included in the New Mexico Oil Conservation Division pre-approved pool combinations for downhole commingling in the San Juan Basin. Working Interest, net royalty interest & overriding royalty interest owners have been notified by certified, return receipt mail on July 28th, 2005. The NMOC has been notified of our intent by submission of a C-103. Downhole commingling will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights.
