Energen frac'd the Pictured Cliffs in this well on July 14, 2005, however, this zone is non-productive and has been temporarily abandoned. The Fruitland Coal was completed as follows:

7/19/05 Set a 4-1/2" bridge plug above the Pictured Cliffs perforations (1566-1624') at 1557'.

7/21/05 Perforate the Fruitland Coal from 1498-1502', 1504-06', & 1510-24' with 80 - 0.43" holes.

7/22/05 Fracture Treat the Fruitland Coal in a single stage with 70Q Foam-20 lb Linear Gel, 10000 lbs 40/70 sd nd and 85,000 lbs 20/40 sand at a maximum sand concentration of 5 PPG.

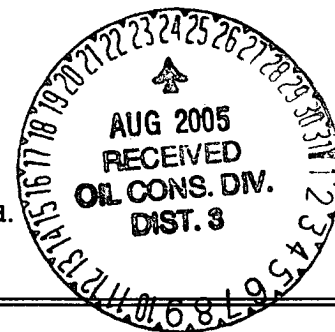
7/23-8/2/05 Flow back frac.

8/3/05 Clean out to the bridge plug at 1557'.

8/4/05 Landed 2-3/8" tubing 1541'.

8/5/05 Rod well up.
