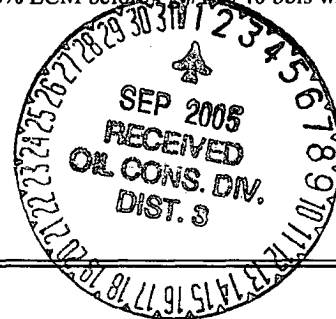

Layed dn 30 jts DP to 2,803'. pmpd Pg #2 -2,803'-2,652' to CVR 50' below OA to 100' above (151' Pg). Layed dn 11 jts DP to 2,460'. pmpd Pg #3- 2,460'-2,290' to CVR 50' #4- 1,683' - 1,518' to CVR 50' below Lower San Jose to 100' above (DP came out to 65' below Lower San Jose top- 165' Pg). Layed dn 44 jts DP to 312' & stood 5 stands in derrick. ND BOPE & ran 5 stands in hole to 312'-50' below Surf Csg Shoe. pmpd Pg #5 -312'- Surface. Layed dn 10 jts DP & topped off w/ cement. All Pgs were the fgs noted above plus 50% excess cement due to possible lost circ. Spotted 20 bbls mud w/ 50% LCM before Pg #1 & 40 bbls w/ 50% LCM before Pg #2.
