**12-6-12: PLUG #4-** Perf 4 holes @ 3122'. Set Retainer @ 3079'. Mix and pump 44 sks below retainer and 13 sks on  
**PLUG #5-** Perf 4 holes @ 2389'. Set retainer @ 2341'. Mix and pump 186 bbls cement below and 80 sks on top of re  
**12-7-12: PLUG #6-** Perf 4 holes @ 479'. Pump 174 sks of Type B Cement to surface with good returns out 9 5/8" csc  
 Cut off wellhead and installed dry hole marker with 48 sks of cement through 13 3/8" , 9 5/8" , and 5 1/2" casing out  
 bradenhead. Moved off location.
