**11-5-12:** Move in and rig up. **11-8-12: Plug #1-** Set a 4 1/2" retainer @ 3112'. **11-9-12:** Pumped 20 sks of Type B cement from 3110' to 2854'. **Plug #2** - Perf 4 holes @ 2850'. Pump 12 sks of Type B cement from 2853'-2698'. **Plug #3** - Perf 4 holes @ 1555'. Set a 4 1/2" retainer @ 1520'. Pumped 36 sks of Type B cement below retainer and 95 sks above retainer. Top of Cement @ 1405'. **Plug #4** - Perf 4 holes @ 152'. Pump 41 sks of Type B cement from 152' to surface out bradenhead. Good returns on cement. **11-12-12:** Dug out and cut off wellhead. Installed markers with 16 sks cement through 8 5/8" casing to surface. Move off location.
