11/30/12 Spud 12-1/4" surface hole at 1200 hrs. Drilled to 135'. Ran 3 jts (127.26') of 8-5/8", 24#, J-55, ST&C new casing and set at 132' KE Cmt with 90 sx (106 cu.ft.) of CI "G" with 2% CaCl2 and 1/8 pps polyflake. Circulated 4 bbls of cement to surface. NU BOP and pressure tested the BOP and choke manifold to 250 psi low and 1,000 psi high for 30 min. - held OK.

12/4/12 TD 7-7/8" hole at 1025'. Ran 25 jts (1002.57') of 5-1/2", 15.5#, J-55, LT&C casing and set at 1008' KB. Float collar is at 982' KB. Cement with 90 sx (185.4 cu.ft.) of CI "G" with 2% SMS and 1/8 pps celloflake and 75 sx (88.5 cu.ft.) of CI "G" with 1/4 pps polyflake. Bumped the plug to 1,500 psi - held OK. Floats held OK. Circulated out 10 bbls of cement to surface. Nipped down the BOP and set the casing slips. Cored the main coal from 816' to 858' and recovered 23' of coal. Took four 1' samples for analysis.
