Burlington had to transfer oil (condensate) from this well to the SAN JUAN 28-6 UNIT 161M located at Unit I (NESE), 1505' FSL & 1185' FEL, Sec. 12, T27N, R6W - API - 30-039-25768. There was a leak in the oil tank and to replace the tank we had to move the oil to a nearby well, Dawn trucking pulled the oil immediately. The SAN JUAN 28-6 UNIT 161N and SAN JUAN 28-6 UNIT 161M have the same lease and interest owners and the oil is produced from the DK/MV formation on both wells, so there is no correlative rights issue. ✓
