Although the interest owners are not identical between these two pools, this same order established approval for subsequent applications for DHC of production in wellbores within the GCU without notice to the unit interest owners. Production is proposed to be allocated based on the subtraction method using the DK projected future decline. That production will serve as a base for production subtracted from the total production for the commingled well. The balance of the production will be attributed to the
