- (1) Cap the CIBP @ 2340' w/ 100' of cmt.;
- (2) Set a cmt. plug from 2150' to 2050', which is above the perforations from 2200' to 2247';
- (3) Set a cmt. plug from 50' below the top of the Mesaverde (1183') to 50' above the top of the Mesaverde (1083');
- (4) Set a cmt. plug from 100' below the base of the surface csg. (400') to the surface;
- (5) Install a dryhole marker;
- (6) Restore the wellsite to its original contour;
- (7) Reseed; and
- (8) Close the access road constructed from the existing two track road to the well
