Elm Ridge Exploration reached a TD of 5655' on the above referenced well on 9-6-05. We drilled a 7 7/8" hole to to 5655'. Ran 4 1/2" 10.5# J-55 casing to 5652'. Pumped 503 sks of 50/50/POZ cement w/ additives. Tailed in with 655 sks 65/35/POZ cement w/ additives. Circulated 30 bbls excess cement to surface. Pressure tested to 1341 PSI.
