XTO Energy Inc. proposes to change the casing and cement on this well to the following:

Surface casing: 8-5/8", J-55, 24# STC casing @ +/- 200' cmtd w/approx 150 sx Type III cmt (or equivalent) containing 1/4 pps celloflake, 2% CaCl2 (14.6 ppg, 1.39 cuft/sx, 6.67 gal wtr/sx). Total estimated slurry volume is 104.25 cuft, 250% excess of calculated annular volume required to circ cmt to surf.

Production csg: 5-1/2", J-55, 15.5# STC casing @ +/- 1750' cmtd w/approx 200* sx Type III cmt containing 8% gel, 1/4 pps Celloflake & 2% Phenoseal (11.9 ppg, 2.54 cuft/sx, 15 gal wtr/sx) followed by approx 100 sx Type III cmt containing 1% CaCl2, 1/4 pps Celloflake & 2% Phenoseal (14.5 ppg, 1.41 cuft/sx, 6.72 wtr/sx). Total estimated slurry volume is 649 cuft, +/- 40% excess of calculated annular volume required to circ cmt to surf.

* Actual cmt volumes will be determined using log caliper volume plus 40% excess.
