Logos Operating, LLC respectfully requests a permit to flare excess gas from the Logos No. 1 well through March 31, 2013 (the anticipated date of pipeline completion to the battery). Logos Operating, LLC will use as much gas as possible to heat two separators at the battery and to power the pumps for the Logos 1, Logos 2, Jair 1 and Jair 2 wells all located on Jicarilla Lease 424. Logos anticipates flare volumes of 5-10 MCF per day for a total estimated volume during this period of 600 MCF-1200 MCF. Flaring this gas will allow the continued production and testing of the Logos No. 1 well and provide for further exploration of Jicarilla Lease 424.
