


Unit Letter N, S19, T27N, R07W, Rio Arriba County, NM



Drill ground bed approximately 135' northeast of #110P wellhead at staked location. Install twin-well solar at staked location and connect to #110P and #268 wellheads and groundbed at lengths below.

#110P Cables:

Negative: 450'

Positive: 15'

Total Ditch: 330'

Note: Disconnect negative cable to the #268 from splitter located on the 28-7 #237 pad approx 1/2 mile away.
