McElvain Energy, Inc. proposes to permanently abandon the well bore below the Greenhorn Dakota top and TA the well until more favorable economics exist and a possible recompletion has been evaluated.

Current Status: Dakota perforations 6590 to 6604. Cast iron bridge plug at 6445. Greenhorn perforations 6354 to 6401.

Proposed procedure:

Pull tubing and tally out of the hole. Cap casing with 50' cement  
Run cast iron bridge plug on wire line at set at 6310.  
Run 2 3/8 tubing open ended to 6300 and circulate hole clean with 2% KCL water containing corrosion inhibitor.  
Rig down service unit.  
Run MIT test to 500 psi for 30 min as per BLM procedure.  
Shut well in.
