


Unit C, S34, T28N, R07W, Rio Arriba County, NM



Drill ground bed approximately 110' northwest of #131N wellhead at staked location. Install meter pole near entrance of location across the road from Jemez distribution pole #45980. A transformer and meter must be installed. Install 40-16 rectifier at staked location and tie-in to meter pole, groundbed and #131N wellhead at lengths below:

#182F Cables:

Negative: 110'

Positive: 15'

UGAC from meter pole: approx 80'

Total Ditch: 205'
