


## Grenier B #3N

Letter K, S05, T29N, R10W, San Juan County, NM



Drill ground bed approximately 155' northeast of #3N wellhead at staked location. Replace existing rectifier-located on southwest side of B #3 location-with 40-16 three well rectifier and install cables to #3N and new groundbed and connect #3N, #3 and #6 wellheads. Install cables to ground bed, and #3N wellhead at lengths below.

#3N Cables:

Negative: 525'

Positive: 370'

Total Ditch: 525'
