It is intended to drill and complete the subject well in the Blanco Mesaverde (pool 72319) and the Basin Dakota (pool 71599). The production will be commingled according to Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production.

Proposed perforations are: MV - 4136' - 5105'; DK - 6795' - 7049' **These perforations are in TVD.**

COPC will use some form of the subtraction method to establish an allocation for commingled wells.

Notification of the intent to commingle the subject well was sent to all interest owners via certified mail on 2/19/13. No objections were received.
