1. RUPU. NDWH, NUBOP. *Run a current BHT + casing valve gas analysis before proceeding a OCD witness is required.*
2. POOH w/ production tbng. *Verbal OCD approval is required before sqz.*
3. RUWL. RIH sector bond tool and record form 1100' to surface. RIH MFC log from 1100' to surface to locate csng failure. *- Set CBP @ ± 1100'*
4. TIH composite cmnt retainer to 160'. Establish injection rate.
5. RU cmnt and circulate cmnt to surface. Sting out of cmnt retainer and circulate excess cmnt to surface. WOC.
6. Drill out cmnt and pressure test squeeze to 500psi for 30 minutes. Resqueeze if necessary.
7. C/O to PBTD. TIH w/ production tbng and return well to production.
