

Describe Cause of Problem and Remedial Action Taken.\*

A hole in the oil production tank developed causing the release of 175 BBLs condensate and 15 BBLs produced water. The release remained within the berm with 85 BBLs condensate and 4 BBLs produced water recovered. The well was shut in and impacted surface soil was hydrovac'd.

Describe Area Affected and Cleanup Action Taken.\*

Excavation will be required. ConocoPhillips will have the soil assessed and excavation will occur. Per the request of Brandon Powell, OCD, excavation will be expedited. **Contaminated area was excavated and soil transported to land farm. January 28, 2013, COP received approval to backfill from BLM & NMOCD following the application of Potassium Permanganate to the base of excavation.**
