
Energen Resources would like to recompleate the exisiting West Lindrith Gallup Dakota pool. The existing perfs are from 7270'-7303' at 1spf & 7374'-7380', 7386'-7400 at 2spf, and the estimated new perforations are 6273'-6449' at 3 spf. A CBL will be run from around 7200' to surface to determine TOC. Then, perforate and fracture. Clean out to PBTD, then return full production from all perforations.
