Cemented casing w/165 sks Premium lite FM + 3% bwoc CaCl2 + 0.25 lbs/sk Celloflake + 5 lbs/sk LCM-1 + 8% bwoc Bentonite + 0.4% bwoc Sodium Metasilicate + 0.4% bwoc FL-52A + 112.3% fresh water (slurry yield 2.13 cu.ft/sk, total 351 cu ft) as lead slurry followed by 75 sks Type III cement + 1 lbs/sk CaCl2 + 0.25 lbs/sk Celloflake + 0.2% bwoc FL-52A + 59% fresh water (slurry yield 1.38 cu ft/sk, total 104 cu ft). Total slurry for the job 455 cu ft. Displaced w/38 bbls water. Circulated 10 bbls clean cement to surface.
